Scott said that he's worked out how to fill the corney kegs from the serving tanks under pressure. Filling from the fermenter, for those of you who want unfiltered beer, can also be done—timing is more critical however, and you'll have to carbonate or prime (and fine) yourself—talk to Scott if that's your preference.

SODZ 1999 Financial Report

I am happy to report that SODZ is on an excellent financial foundation despite a decrease in revenues compared to 1998. The club ended the year with a cash balance of \$1,521.45.

Total revenue for 1999 was \$775.75, compared to \$961.05 in 1998. The primary reason for the fall-off was a decrease in paid memberships of \$180. SODZ had only 24 dues-paying members in 1999, down from 33 the previous year. This reflects the national trend toward less interest in homebrewing, but is disturbing nonetheless.

The good news is that expenses were pared back considerably, leaving the bottom line relatively unchanged. Although we incurred new, one-time expenses for incorporation and not-for-profit status (see below), newsletter expenses were slashed dramatically due to Internet distribution. We also purchased our tasting glasses in 1998 as well as a lot of brewing materials from Wines, Inc., which were one-time expenditures.

In 1999, SODZ became a corporation and also attained not-for-profit status under Section 501(c)(7) of the Internal Revenue Code as a social club. We wanted corporate status so that our members would have limited liability in case of any drinking-related incidents. We then sought not-for-profit status so we do not have to pay taxes. Our president, Bonni Katona, spearheaded this effort. Thanks, Bonni.
